O le tulafono laiti o faamoemoega mo matātā faalesoifua maloloina ma tagata o faaaogāina auaunaga ma aiga (le code) o lo o folasia ai alafua o faamoemoega e tatau na galulue ai matātā faalesoifua maloloina ma tagata o lo o faaaogāina auaunaga, aiga ma tagata auā le fuafuaina, faatulagaina, faataunuina, ma le toe iloiloina o auaunaga faalesoifua maloloina.

E faatulafonoina le tulafono laiti lea e le Pae Ora (Healthy Futures) Act 2022 ma e faavae i luga o aga taualoa a le matātā tau soifua maloloina. E tatau i matātā tau soifua maloloina na faatino galuega e tusa ma le tulafono laiti ma e tatau na saunia lipoti faaleausaga i tulaga na faaaogā i ai le tulafono laiti.

O aga taualoa a le matātā tau soifua maloloina o lo o aofia ai aga taualoa o le Te Tiriti o Waitangi (le Treaty of Waitangi) na faamaonia e le Waitangi Tribunal e tusa ma

le Hauora Inquiry na fai. E aofia ai aga taualoa o le tino rangatiratanga (pulea saoloto); īritetanga (laugatasia); whakamaru (puipuiga); kōwhiringa (filifiliga); ma le pātuitanga (faapaaga).¹

E le suia e le tulafono laiti lenei le Code of Health and Disability Services Consumers' Rights (Code of Rights).² E maoti i le Code of Rights aiatatau taua e tatau i auaunaga na tausisia i le faataunuina o auaunaga mo tagata o faaaogāina auaunaga, ae o le tulafono laiti lenei o lo o folasia ai tulaga moomia mo matātā tau soifua maloloina e tusa ma faiga e tatau na galulue faatasi ai ma tagata o faaaogāina auaunaga, aiga ma tagata auā le fuafuaina, faatulagaina, faataunuina, ma le toe iloiloina o auaunaga faalesoifua maloloina.

Faamoemoega o talatalaga

1. I le faataunuina ai o talatalaga ma tagata o faaaogāina auaunaga, aiga ma tagata, e tatau i matātā tau soifua maloloina na:

- 1.1 limataitaiina galuega e tusa ma aga taualoa mo matātā tau soifua maloloina o lo o tusia i le fuiupu 7 o le Pae Ora (Healthy Futures) Act 2022
- 1.2 faataua ma amanaia le taulai o le silasila i le aogā o le te ao Māori ma saunia avanoa mo Māori e faatino le pule e faia ai faaiuga fai
- 1.3 faataua talatalaga: o talatalaga e faavae i luga o le faatuatuaga, agaga moni, felagolagomai, manino, ma e naunau e faasoa ma maua lesona aogā mai le tasi i le isi. E faaaofia uma ai le faitau aofai o le atunu ma i latou e patino lava o latou manaoga
- 1.4 fefaasoaii taitaiga: e tutusa le faatauaina o le malamalama ma le tomai e maua mai ia i latou na ola ma soifua i tulaga na aafia ai ma fomai ma isi tomai. O tagata o faaaogāina auaunaga, aiga ma tagata o i latou nei o tomai faapitoa e tusa ma tulaga na ola ma soifua ai, e maua mai ai auala e tali atu ai auā le faaleleia o le faiga faavae tau soifua maloloina

1.5 faalauiola tulaga lelei ma le saogalemu: o tulaga na ola ma soifua ai tagata o faaaogāina auaunaga, aiga ma tagata ma e faalagolago i tulaga lelei tau soifua maloloina ma le saogalemu, ma le saogalemu o tu ma agaifanua

1.6 faalauiola tulaga e laugatasia ai: e taua le fesootai ma tagata e sili atu manaoga tau soifua maloloina, aemaise tagata Māori, tagata Pasifika, ma tagata e iai manaoga faapitoa. O auala nei e atagia ai le agatonu o se tali atu i tulaga e laugatasia ai pe a tau auala atu i tagata o faaaogāina auaunaga, aiga ma tagata.

- 2.1** fuaitinoina faatasi ma tagata o faaaogāina auaunaga, aiga ma tagata o tulaga o le a ave i ai le faamuamua e faalapotopotoga, o le faagasologa o galuega ma le toe iloiolina, ma o lo o fai i ai se sao o tagata o faaaogāina auaunaga, aiga ma tagata i tulaga uma o faagaioia ai
- 2.2** faaaogāina o tulaga na ola ma soifua ai, e aofia ai faamaumauga i tulaga na feagai ma tagata o faaaogāina auaunaga e fua i ai mea e fia faaleleia i auaunaga tau soifua maloloina ma ia taulai i le tuuitiitia o tulaga e le o laugatasia ai tagata, aemaise mo tagata Māori, tagata Pasifika, ma tagata e iai manaoga faapitoa
- 2.3** faatinoina se tali atu i le tuuitiitia o tulaga e le o laugatasia ai tausiga faalesoifua maloloina e auala atu i le galulue faapaaga o matātā uma faatasi ma isi faalapotopotoga ma faiga faapaaga ma tagata o faaaogāina auaunaga, aiga ma tagata
- 2.4** faamautinoaina le maua o faamatalaga, punaoa, ma avanoa e fesoottai ai ma tagata o faaaogāina auaunaga, aiga ma tagata uma, ma aveesea mea o faalavelavea ai le mafai ona auai atoatoa ma anoa talatalaga ma tagata³
- 2.5** faatamaoaigaina tagata o faaaogāina auaunaga, aiga ma tagata i faiga ma auala e mafai ai na fai so latou sao ma anoa manatu ma saunaia taiala faavae o atagia ai tulaga nei
- 2.6** faamautinoaina tulaga o le a faatonuina ai le faatinoga o auaunaga, o lo o faatino i se auala e mafai ai e tagata o faaaogāina auaunaga, aiga ma tagata na fesoottai i tulaga uma e pei ona faatonuina e le tulafono laiti.
