Re: PMMRC DHBs to explain their high mortality and NE rates

Dear

I refer to your official information request dated 22 April for a copy of correspondence to DHBs by the Commission, to explain their high mortality and Neonatal Encephalopathy (NE) rates.

The information you have requested is enclosed. This information is from behalf of the Perinatal and Maternal Mortality Review Committee (PMMRC). The email advises that the (then) soon to be released report identifies those DHBs that have a significantly higher rate of perinatal mortality or neonatal encephalopathy than the national rate. Further detail is provided in the letters attached and sent on 9 February 2021. All DHBs with higher rates of perinatal mortality and NE were notified. These DHBs include:

- Capital Coast District Health Board (CCDHB)
- Northland District Health Board (NDHB)
- Waikato District Health Board (WDHB)
- Counties Manukau District Health Board (CMDHB)

There was one response from a Clinical Director of Obstetrics and PMMRC local coordinator thanking the Commission for their correspondence and asking two questions. These have been resolved with the Neonatal Encephalopathy Working Group (NEWG) Chair (a colleague) within WDHB. The Commission has also spoken with the NEWG Chair, who advised that the WDHB are internally exploring their rate of NE over recent years, paying particular attention to the number of babies who are from within the WDHB versus those babies transferred in from other areas.
