Thank you for your request of 2 November 2020. We received your original request for official information on the 30 July 2020, requesting data on suspected suicide differentials for each DHB on adverse events and we advised that due to COVID-19 and public release of the adverse event data we would not be able to provide this data until 10 December 2020.

As per your correspondence on 30 July 2020:

I am now requesting the data that your Office has kindly provided in the past; namely the suspected suicide data differentials for each DHB. The ideal would be for it to be provided in the same format that has been used previously, this year capturing the data from 2015 to the latest reporting period 30 June 2020.

Please see attached our response (appendix one). The information provided is assembled from the Commission's database of mental health adverse events, which will not necessarily return exactly the same totals of events as the Office of the Director of Mental Health's published reports, or our annual summary. Data is provided to 5 November 2020.

This information does not include Ministry of Health population estimates for the 2019/2020 year. These are released by the Ministry of Health in December of each year. Additionally, appendix one of our reply to you dated 16 April 2018 sets out some caveats and limitations of the data we have provided to you.

Please note that the Commission publishes some of its OIA responses on its website, after the response is sent to the requester. The responses published are those that are considered to have a high level of public interest. We will not publish your name, address or contact details.
